Membership policy

You must be 50 or older to become a member. However, a spouse under 50 may join. Each person must fill out a form and sign the waiver. Couples may pay with one check, a total of \$60 for two people. We need your birth date, including year, on file since our activity leaders negotiate discounted tickets whenever possible.

You don't have to ski to join Club 50. We enjoy many warm weather activities, too.

Guests

Guests and newcomers are always welcome at dinners; however, reservations are necessary.

Non-members may join us for local "active" events such as bike rides, golf outings, hikes, and local kayaking trips. Guests will be asked to sign liability waivers. Guests may attend two events before joining the club.

Ski and summer trips

You must be a member to apply for a ski or other out-of-town trip. You may send in your membership application and a trip application at the same time.

Non-Chicago area membership

We welcome our skiing and hiking friends from around the country. However, sign-up priority for trips is given to Chicago area residents during a four-week period after trip flyers are mailed. Then reservations are open to out-of-state residents. Ski trip flyers are usually mailed in July.

Note: Out-of-state members who joined the club prior to 2003 are not affected by the priority wait period.

Chicagoland Club 50 — Ski & Sports Activity Waiver

By executing the application for membership in Chicagoland Club 50 — Ski & Sports (the Club), I *hereby acknowledge that many of the activities of the Club are inherently dangerous, including but not limited to* ski trips, bicycle rides, hiking, camping and other sports and recreation activities that may put the applicant in harm's way. That some of these activities may be strenuous activities beyond the capabilities of some people, and may cause minor, severe and/or permanent injuries or death to people who are not in sufficient physical fitness, training or experience. I have made my own determination as to whether or not I can participate in the Club-activities. I also recognize that advice dispensed through the Club may or may not be appropriate for me and it is my responsibility to make this determination.

I acknowledge that some of the Club's activities may be a test of a person's physical and mental limits and carries with it, regardless of physical fitness or experience, the potential for serious injury, death, and property loss. I assume the risk of those losses by participating in any activity I choose to participate in. I certify that my level of fitness is appropriate to participate in those activities I voluntarily choose to participate in and that I have not been advised to not participate in those activities I choose by a health care professional.

1, for myself, my past and future agents, attorneys, representative, predecessors, successors, assigns, heirs and executors do waive, release and discharge the Club, its past, present and future officers, directors, agents, employees and volunteers, any club members, or participants from (in conjunction with Club events), any and all manner of liability, claims for damages, causes of action, proceedings, compensation, attorneys' fees, costs and expenses of suits, claims and demands whatsoever, which may arise in the future from my participation in Club events. I acknowledge that there may be hazard, wildlife or hidden objects present during Club events. I assume all other risks associated with participating in the Club events I choose to participate in.

I agree not to sue any of the Club members, directors, officers or volunteers for any and all claims made or liabilities which may be assessed against them as may be discharged herein.

I Indemnify and Hold Harmless the Club parties from any and all claims of liabilities assessed against them as a result of 1. my actions, inaction or negligence, 2. the action, inactions or negligence of the Club parties and others hereby -indemnified, 3. the conditions of the equipment, weather, or area where the Club event took place, 4. or any harm, injury or damage caused by an occurrence during the Club event or involving the Club.
