Long Weekend at Granite Peak, Wisconsin

Arrival: Saturday, January 12, 2019

Departure: Tuesday January 15, 2019

For those of you with an unlimited love of skiing, but a limited amount of vacation time, Club 50 will be travelling to beautiful Wausau, Wisconsin to ski at Granite Peak, Wisconsin's largest and tallest ski area. Granite Peak has a 700-foot vertical drop and 75 runs. We will be staying 2 or 3 nights and skiing 2 or 3 days. As the resort is about 279 miles Northwest of Chicago, Club 50 members will be responsible for their own transportation, but we will establish a sign-up system for those who want to car pool.

Compare Granite Peak to your favorite Midwest ski area. You'll find that Granite Peak is taller, has more runs, more new chairlifts, and a new base village. Granite Peak also has the two longest/highest high-speed chairlifts in the Midwest. And no one can match the City of Wausau, with its great restaurants, affordable, high-quality hotels, theatre, and multitude of entertainment choices. The train station shown in the Wausau Insurance commercials is now a distillery/bar. (If you want to do some apres ski/shopping.)

Estimated Trip Fee of no more than \$400.00* includes:

- **3** nights hotel lodging, double occupancy. Single supplement available.
- **3** day lift ticket to Granite Peak Ski area.
- Wine & cheese party Saturday and Sunday evenings.
- Pizza party on Monday night.
- There is no trip insurance provided for this trip. Lift ticket cancellations will be issued as a rain check for future lift tickets.

* Your final price, if you decide to join us, will be reduced if you are over 65 and if you ski only 2 days instead of 3. If we have 20 or more skiers, lift tickets will be \$48/day rather than 72/day Adult and 63/day Senior tickets.

NOTE: For those of you who are planning other skiing besides the 3 organized ski trips, **Chestnut Mountain** is again offering their **Midwest Premier Pass** that also gets you free or discounted skiing at **Granite Peak, WI (2 days free, 50% off additional)**, Sundown Mountain, IA, Crystal Mountain, MI, and Lutsen, MN. An adult season pass costs about \$399. The photo ID passes can be bought online but **MUST** be picked up at Chestnut Mountain.

If you are purchasing an **Epic Pass** for the Crested Butte or Heavenly trips, your pass will save you \$20.00 off the window ticket price of \$68-\$78 at Granite Peak. This could be helpful if you want to arrive early and ski on Saturday.

THIS IS A LEGAL DOCUMENT AND A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

In consideration of my participation in the CHICAGOLAND CLUB 50 Trip listed above (the “**Trip**”), I, [Print Participant’s Name]:

hereby acknowledge that I am aware of and understand that any and all snowsports activities, including but not limited to skiing, snowboarding and racing (“**Snowsports**”) are hazardous activities and dangerous sports which can lead to property damage, serious injury or even death and **that injuries are a common and ordinary occurrence**. I understand and voluntarily agree to personally assume any and all of the liability and risks of Snowsports. I understand that these risks include, but are not limited to, contact with permanent and temporary fences, gates, posts, trees, snow-making equipment, lift equipment and towers, rope tows and surface lifts, light poles, signs, buildings, roads and walkways, padded and non-padded barriers and obstacles, grooming equipment, snowmobiles, and collisions with other skiers and/or snowboarders, spectators and other persons, and other natural and man-made hazards, equipment failures, exceeding one’s own abilities, the design, location, construction, inspection, maintenance, and repair of the ski area, changes in terrain, weather and snow surfaces.

Further, I agree it is solely my responsibility to determine the safety of the ski area’s facilities, including but are not limited to, ski trails and off-piste skiing and/or snowboarding, for my ability level. I acknowledge that the risks in Snowsports can be reduced by my taking lessons, by my abiding by the Skier Responsibility Code and by my using common sense.

Further, if this Trip includes travel to or through any country other than the United States (“**Foreign Country**”) at any time for any reason, I agree it is solely my responsibility to ascertain prior to the Trip that my travel to or through such Foreign Country will be acceptable to said Foreign Country, including but not limited to, my passport and/or under all laws and regulations of such Foreign Country. **I understand that laws and regulations of Foreign Countries can be and often are much different that the same laws and regulations of the United States.** By way of example only, a conviction of driving under the influence of drugs or alcohol in the United States can bar a person from admittance to Canada.
