CLUB 50 GOES TO BOYNE MOUNTAIN, MICHIGAN

Arrival: Sunday, January 26, 2020

Departure: Wednesday, January 29, 2020

For those of you with an unlimited love of skiing, but a limited amount of vacation time, Club 50 will travel to Boyne Mountain, Michigan to ski at Boyne Mountain and/or Boyne Highlands. Boyne Mountain has a 500-foot vertical drop and 60 runs; Boyne Highlands has a 550-foot vertical drop and 53 runs. For those who are into alternative skiing styles, each of the two resorts offers 35 kilometers of cross-country skiing trails. We will be staying 3 nights at the Mountain Grand Lodge and skiing 3 days. The Mountain Grand Lodge is connected to the Avalanche Bay Indoor Waterpark and the game room via a sky bridge. The restaurants in Boyne Mountain's village have a variety of options from fine dining to pub fare to taco trucks.

As the resort is about 370 miles northeast of Chicago, Club 50 members will be responsible for their own transportation, but we will establish a sign-up system for those who want to car pool.

NOTE: For those of you who have the Ikon Base Pass, your pass is good for up to 5 days of skiing at each of the two resorts. For those of you who are 65 and older, **seniors ski free Mondays through Thursdays with paid resort lodging. Resort lodging guests who are 80+ years old ski/ride free every day, all season.**

Trip Waiver And Release Of Liability

THIS IS A LEGAL DOCUMENT AND A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

In consideration of my participation in the CHICAGOLAND CLUB 50 Trip listed above (the “**Trip**”), I, [Print Participant’s Name]:

hereby acknowledge that I am aware of and understand that any and all snowsports activities, including but not limited to skiing, snowboarding and racing (“**Snowsports**”) are hazardous activities and dangerous sports which can lead to property damage, serious injury or even death and **that injuries are a common and ordinary occurrence**. I understand and voluntarily agree to personally assume any and all of the liability and risks of Snowsports. I understand that these risks include, but are not limited to, contact with permanent and temporary fences, gates, posts, trees, snow-making equipment, lift equipment and towers, rope tows and surface lifts, light poles, signs, buildings, roads and walkways, padded and non-padded barriers and obstacles, grooming equipment, snowmobiles, and collisions with other skiers and/or snowboarders, spectators and other persons, and other natural and man-made hazards, equipment failures, exceeding one’s own abilities, the design, location, construction, inspection, maintenance, and repair of the ski area, changes in terrain, weather and snow surfaces.

Further, I agree it is solely my responsibility to determine the safety of the ski area’s facilities, including but are not limited to, ski trails and off-piste skiing and/or snowboarding, for my ability level. I acknowledge that the risks in Snowsports can be reduced by my taking lessons, by my abiding by the Skier Responsibility Code and by my using common sense.

Further, if this Trip includes travel to or through any country other than the United States (“**Foreign Country**”) at any time for any reason, I agree it is solely my responsibility to ascertain prior to the Trip that my travel to or through such Foreign Country will be acceptable to said Foreign Country, including but not limited to, my passport and/or under all laws and regulations of such Foreign Country. **I understand that laws and regulations of Foreign Countries can be and often are much different that the same laws and regulations of the United States**. By way of example only, a conviction of driving under the influence of drugs or alcohol in the United States can bar a person from admittance to Canada.

Further, I agree on behalf of myself, my heirs, survivors, guardians, legal representatives or assignees to **HOLD HARMLESS AND RELEASE CHICAGOLAND CLUB 50** and all of their board members, officers, sponsors, organizers, agents, representatives, volunteers, workers, instructors and employees, and those of the ski area at which the Trip is held, and any and all fellow Trip participants (“**Releasees**”) of and from any and all responsibility, and/or liability for any and all property damage, personal injuries, death and any other losses or damages of any kind which I may suffer or cause during and as a result of my participation in the Trip and any related events or social functions, **even if such liability is caused in whole or in part by the negligence or other fault of CHICAGOLAND CLUB 50 or other person or entity released in this Trip Waiver and Release of Liability.** I agree not to bring any action or lawsuit against CHICAGOLAND CLUB 50 or any other person or entity released in this Waiver and Release of Liability for any injuries, damage, death or any other losses.

I agree to release, forever discharge, indemnify, defend, and hold harmless the Releasees of and from any and all claims, suits, costs and attorney’s fees for damage, personal injury and/or death to me or damage to my property resulting from the negligent actions or omissions for the Releasees.

Further, in consideration of my participation in the Trip, I hereby grant and release, without further compensation, to CHICAGOLAND CLUB 50 the right and permission to use, reproduce and publish my photographs, name and likeness, whether in still photographs, motions pictures, audio-video recordings, or other reproductions of me including my voice and features with or without my name, for any promotional purposes involving CHICAGOLAND CLUB 50 and its sponsors, or for any other CHICAGOLAND CLUB 50 purpose whatsoever, except for the endorsement of commercial products or enterprise unrelated to CHICAGOLAND CLUB 50.
