Again this season we'll enjoy a wonderful week at Snowmass, Colorado, staying at our beloved ski in/ski out Mountain Chalet. The Mountain Chalet could not be more conveniently located! It is the first building down the slope from the Snowmass Village mall (where the ticket pavilion is).

The Mountain Chalet serves a huge hot breakfast every morning. Then it is out the door to ski down the slope to the lifts. We ski back to the Chalet for a soup lunch, parking our skis just outside the door.

With its varied terrain of wide slopes, Snowmass provides runs for all levels of ability, from beginner to expert. Our lift tickets allow access to the trails at Aspen Mountain, Highlands, Buttermilk and Snowmass ski areas.

After skiing, we relax and socialize in the hot tub while watching others make the last run of the day. Some ski right up to the hot tub!

Each evening we get together for a wine and cheese party where we talk about the day's skiing, get acquainted with new people and make dinner plans.
